#### **BE ALERT & BE CAREFUL**

**SAFETY MUST ALWAYS COME FIRST:** If in doubt, ask someone. Your knowledge and skill are what makes each of us safe and courteous operators. Be courteous and friendly to the people who come to our show. Let these visitors know that we appreciate them coming to the show. Without these visitors there would be no show.

- DO NOT MAKE ANY ADJUSTMENTS WHILE EQUIPMENT IS MOVING OR OPERATING: No part of our show is so important that we cannot wait for adjustments to be made safely.
- Drive your equipment responsibly.
- NO RIDERS on equipment while it is moving.
- Operate equipment in low gear.
- Block wheels if there is any danger of moving or rolling, especially if someone releases the brake or clutch on a hill.
- When doing any belt work, be sure engine is in alignment with the other machine. Belts that slip off the pulley
  may cause serious injuries. The operator is responsible for ensuring that people are a safe distance before
  starting.
- Be extremely careful when handling fuel. Stop engines when putting fuel in.
- Tractors and Equipment should never be left unattended when they are running.
- Be incredibly careful when pulling equipment. Have the correct and adequate hitch pin and receiver hitch and ball.
- Know your surroundings when loading and unloading. **Only load and unload in specified areas.** If you do not know those areas, please ask.
- Turn off fuel tank when parked.
- Know where fire extinguishers and emergency contacts are located around you.

• Parade Time: Be ready at parade time and line up only in designated staging area. There will be a coordinator to tell you in what order equipment will go into the parade. Do not cut into line. If you are unsure of the process, check with the Registration Table.
